HELPING ENTREPRENEURS THRIVE

PATRICK BROWER PROVIDES FREE BUSINESS COACHING IN GRAND AND JACKSON COUNTIES

The most common issue for local businesses in Grand and Jackson counties is a lack of employees, yet Patrick Brower with Grand Enterprise Initiative and Jackson Enterprise Initiative is helping entrepreneurs work through this challenge and others through grassroots economic development efforts.

Brower, enterprise facilitator for the two non-profit organizations, works individually with business owners, providing free and confidential business coaching. Mountain Parks Electric is a proud sponsor of the Grand and Jackson Enterprise Initiative organizations through MPE's Unclaimed Capital Credits Fund. Brower shared an update with the MPE board at its February meeting.

In 2023, he helped entrepreneurs create six new businesses in Grand County and added a total of 32 new clients. Even though activity dropped a little from 2022, in which 49 new clients were added, several of the businesses Brower works with, particularly in the Winter Park area, are thriving.

Adam Nicholson, owner of San Util Design, LLC in Winter Park, credits Brower with helping his business expand. The business designs and builds hand-made bike gear bags and accessories. Along with helping the business expand, Brower worked with Nicholson on refining his overall business model. Together, the two settled on a new location for the business in Winter Park that has improved its visibility and direct retail sales. The company also launched a new line of winter backpacks this season. These changes have allowed them to grow to three employees who work with Nicholson.

MPE INTERNSHIP SPARKS INTEREST

MICHAEL MCCOY ENJOYED EXPLORING SEVERAL CO-OP CAREER PATHS

Michael McCoy may say his internship at Mountain Parks Electric opened his eyes to several possible career fields. The staff members who Michael shadowed have said how impressed they were with Michael's intellect, curiosity, and work ethic – that he will be successful no matter what path he chooses.

Michael, a junior at Middle Park High School, was named the school's Intern of the Month in February.

He was interested in an internship with MPE's Engineering Department because he had been looking into engineering as a possible future career path, and that the MPE experience would also offer opportunities to branch out and explore other areas.

He started when the school returned from Christmas break, coming to the MPE offices for an hour and a half in the afternoons, four days a week. He initially learned what engineers at MPE work on, and Susan "Sue" Henderson, manager of Engineering, showed him the basics of using Excel to work with data.

"Learning how to use Excel was really fun, surprisingly," said Michael. "Sue showed me the basics and I spent a week and a half learning and becoming more efficient, watching YouTube videos, and talking to Sue. Then, I could do it in a fraction of the time"

In the end, he was able to utilize the program to take raw substation energy usage data to divide and create percentages on given dates for demand at each substation.

He was also given a tour of a substation. Leading up to this outing, he said he did some research on substations.



"There is more that goes into it than you'd expect. You pass them every day, but there is so much going on in there – engineering, technology, and the thought behind it in general – we take it all for granted," he said. "I was 20 minutes late getting back to school that day, but it was worth it!"

Other MPE days that stand out in Michael's memory include his outing with Adam Paulson, manager of Operations, when they went out in the field and watched linemen string powerlines on a recently replaced pole in Grand Lake. He also enjoyed learning about MPE's warehouse processes.

Michael has lived in various places in Colorado. Before moving to Granby in the seventh grade, he spent a year traveling with his family in South America. He was a part of the Middle Park High School Nordic team that made it to the state competition this year, and he runs in various events on the track team. He is also helping get the Model UN Club started at the high school.

"With Patrick's assistance, we are positioning our operation to be eligible for loans and financing in about a year to push our production to a higher level for online and local sales," Nicholson wrote in a testimonial available at www.grandei.org/testimonials.

South + West Charcuterie, Wine, Catering and Events is another local business startup that gives credit to Brower. The mother-daughter-duo of Rachael Thackston and Jordin Fletcher had Brower help them with their business plan and to gain an understanding of the market in Winter Park. Although the pandemic delayed their initiative, they reconnected in 2023 and Brower helped them secure a location and get their business up and running. Thackston said they continue to consult with Brower. "We've added three new jobs to the local economy, and we are busy," she wrote in her testimonial.

In North Park, three new clients were added in 2023, also a bit down from an average of around five new clients a year in that area. Brower admitted that it is a tougher market up there, but that he also works with the North Park Chamber of Commerce and North Park Heart and Soul in helping that community with planning and future growth. Two of his active clients in Jackson County include a new service organization and another business working on expanding.

Brower has been serving our local community for more than 12 years, utilizing his training in enterprise facilitation business coaching — a form of community-driven and client-centered economic development that supports the growth and sustainability of locally-owned and operated businesses.
