Mountain Parks Electric executes Letter of Commitment for more than \$100 million in New ERA grant funding

GRANBY, CO – Mountain Parks Electric, Inc. (MPE) executed a letter of commitment with the United States Department of Agriculture (USDA) Rural Utilities Services today for the Empowering Rural America (New ERA) program for a total grant funding amount of \$100,321,532 over 20 years.

This New ERA investment will be used for MPE to procure more than 300,000 megawatt hours of renewable clean energy through power purchase agreements in rural areas of Colorado. This will power nearly 18,500 homes annually.

The New ERA funding requires an impactful Community Benefit Plan (CBP). MPE submitted a comprehensive CBP that will advance and promote scholarships and apprenticeship programs, expand support of affordable housing and services for lower-income households, stabilize costs to rural cooperative members, and reduce climate pollution by over 201,000 tons annually. Projects will reduce greenhouse gas emissions by over 201,000 tons annually.
