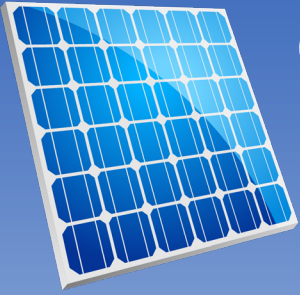

CPP IN THE COMMUNITY

LAUNCH OF ACCELERATOR GRANT PROGRAM

In 2023, the Clean Power Program offered community member, local business owners, and non-profits the chance to apply for an accelerator grant to help support clean-energy projects in the MPE service territory.

With \$30,000 in potential funds, the CPP goal was to expand its impact beyond individual residential solar and renewable projects to larger-scale project suitable for commercial uses.

Through this grant program, the CPP is working with the Grand County Habitat for Humanity to possibly provide ongoing solar installations on the organization's projects, as well as with the Town of Granby on a possible 25kW solar array in association with the town's new water treatment plant.
